## 5-State Breeders Pole Bending Maturity Rules

### \$500 added and prizes

1. To be eligible for the Pole Bending Maturity, horses must be registered and sired by a 2024 5-State Stallion or a Stallion previously paid into the 5-State the year the horse was born.
2. Horses four and under are not Maturity eligible and horses may not enter the Futurity and Maturity in the same year.
3. All riders must be designated by July 1, 2024. Rider changes after that date will need to submit a RIDER CHANGE form along with the \$20 rider change fee.
4. There will be one go-round.
5. Entry fee will be \$70.00 of which \$20 will be withheld from each entry for an administration charge and one exhibition. Pre-entries close on June 17, 2024.
6. Late entries will be accepted until 5pm on June 29th, 2024 via email at [5stateentryoffice@gmail.com](mailto:5stateentryoffice@gmail.com) with a \$25 late fee. Buyouts will be taken ONLY on horses paid in full and can only be done between June 17<sup>th</sup> and 5pm June 29<sup>th</sup>, 2024. Buyout Form and \$25 buyout fee must be submitted to LI Productions by 5pm June 29<sup>th</sup>, 2024. Entry fees are to be exchanged between the two parties and are not the responsibility of the 5-State Office or LI Productions, LLC.
7. The Pole Bending Maturity will be paid on a progressive payout with a 1.5 second split.
8. A photocopy of the front and back of the registration papers must accompany the nomination.
9. Payments made with insufficient funds checks will be assessed a \$30 fee in addition to any late fees.
