5-State Breeders Barrel Maturity Rules

\$10,000 added 2D Maturity

1. To be eligible for the 5-State Maturity horses must be registered and must be sired by: a 2024 5-State Stallion or 100% paid in any previous 5-State Breeders Barrel Futurity or Maturity. Horses may also be eligible based on stallion eligibility during their birth year - contact the 5-State regarding those eligibilities.
2. Horses four and under are not Maturity eligible and horses may not enter the Futurity and Maturity in the same year.
3. There will be two go-rounds.
4. Entry Fees will be \$160.00 of which \$40.00 is an administration charge.
5. The Division of the Purse will be:
30% to the First Go-Round
30% to the Second Go-Round
40% to the Average
6. A 2D Format will be used. No less than 80% of the total purse will be paid out in the 1D with the remainder being paid out in the 2D. The 2D will be a 0.75 second split for each round and 1.5 second split for the average.
7. NOMINATION FEES:
\$80.00 due May 15th
\$80.00 due June 17th
\$160.00 TOTAL NOMINATION FEES
8. Late nominations/sustaining payments MUST BE PAID BY JUNE 17TH, 2024.
LATE NOMINATIONS/PAYMENTS are \$30.00 per late payment.
9. All riders must be designated on or before July 1st, 2024 - rider changes after that date will be \$20 and no changes following check-in. Change of rider form must be filled out and submitted. Should a nominated horse be sold during the course of the payment period, written authorization must be received from the original owner before horse can continue to be paid on. If no authorization is received, horse will be required to re-nominate from the beginning. Unless a professional release is received or there is obvious injury, horses must be ridden by the same rider throughout the futurity and/or maturity.
10. Buyouts will be taken ONLY on horses paid in full and can only be done between June 17th and 5pm June 29th, 2024. Buyout Form and \$100 buyout fee must be submitted to LI Productions by 5pm 5pm June 29th, 2024. Entry fees are to be exchanged between the two parties and are not the responsibility of LI Productions, LLCC or the 5-State Office.
11. Futurity Rules & Regulations will apply to the Maturity as stated in the Futurity rules where deemed appropriate.
